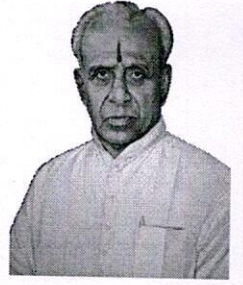

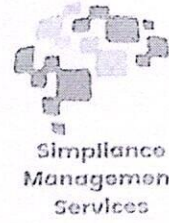

4. Service can be discontinued by giving 30 days notice by either side.

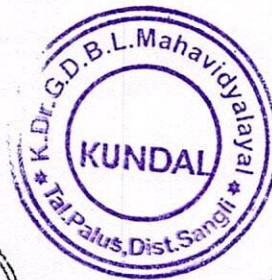
